#### **Director's Report**

Marcie Smedley said the Library Tree Lane Gala took place on December 6<sup>th</sup>. It was a great event and the Friends' really appreciate the board's support. The total raised will be announced at the end of January.

Green Valley Library opening on Monday will be delayed by 1 or 2 weeks as computers are moved out of the computer lab onto the library floor. The computer lab will become a programming space. The extra staffing required to man the computer lab will be used to facilitate opening on Monday. There are great benefits to shifting spaces around. There will be more room for programming and the creation of a STEAM center.

Marcie Smedley said this is Jim Frey's last meeting. He began his term in January of 2012 and has served for 8 years. Marcie Smedley appreciated his leadership on the library board for his experience and professional guidance as she moved into the role of director. Jim Frey's service is appreciated. The board has ordered an acorn for the Giving Tree in Jim Frey's honor. A book, Las Vegas and Clark County Memories, was presented to Jim Frey. Some of the photos

in the book are from Henderson Libraries' digital collection. There will be coffee and bagels after the meeting to thank Jim Frey for his service. Mark McGinty commented that he and Jim Frey have served together for 6 years and Jim Frey is always the calming voice in the storm. Jim Frey has seen the library district through good and bad times. Jim Frey corrected that to "up and down times".

The meeting adjourned momentarily to take a picture of the Board. Jim Frey said thank you, he has enjoyed serving on the board, it has been a very professional and positive experience. Jim Frey added he appreciates the work accomplished over the years and he knows this work will continue.

# 1. Discussion and possible board action regarding reclassifying position 00079 to an ABS Librarian

Michelle Mazzanti, Head of Acquisitions and Bibliographic Services, explained there is a staff member retiring soon that has been here almost 18 years. Various needs have changed over the years, with the initiatives, and the position is being repurposed to librarian to allow greater flexibility and to streamline back end processes. It is hoped this will free up some of the public service initiatives and staff can work on those while ABS brings more into its department to ease the burden on those initiatives.

Mark McGinty asked for public comment. There was none.

Jim Frey asked what the changes in qualifications are. Michelle Mazzanti said the position will require a Master's Degree and the person in the position can do higher-level work. Marcie Smedley said, since the retiring staff person has been here so long, there will no financial impact now, and possibly not for up to 3 years. It is a cost that will be sustainable and be a benefit to the district as a whole. Mark McGinty called for a motion. Jim Frey made a motion to approve reclassifying position 00079 to an ABS Librarian. The vote was unanimous.
